      - Vine Project Team: Making good progress with another meeting in a week. The group is getting more consensus on where they will land; expect to have something solid to bring to EB by the end of the summer, with communication to the congregation in the fall.
    - **2023-24 Draft Ministry Plan** Congregational Meeting representation: This week elders need to contact the leader of their assigned ministry to be sure someone is at the June 25 congregational meeting to represent that ministry if questions arise; if the leaders is not available, the elder may be that person.

## C. Discussion/Action Items:

## 1. Monthly Annual: Lead pastor's review of staff (with growth goals); Review of lead pastor

Pastor Kevin is still in the process of working with staff through their evaluations and goals. He shared the general functioning of staff, how they have done on their growth goals for the past year, and the potential growth goals moving forward. Pastor Kevin also shared thoughts on his goals for the coming year after initially reviewing the evaluation input from the elders.

#### 2. Elders' role in baptisms

Pastor Kevin shared his initial thoughts on a significant role for elders in baptisms, specifically for those in the elder's flock. He sought elder input on the role(s) that he shared. He will share his write up with elders as he publishes it.

## 3. Individual prayer support during worship

Pastor Kevin shared his thoughts on logistics for initiating individual prayer support during worship, beginning with those who are requesting public prayer. The overall purpose is to elevate prayer as an active function during worship, beyond the public prayer. Elders raised questions and shared ideas for effectively implementing this practice. This may be introduced in August and put into practice in fall.

Elder showed overall support for developing this practice.
